

What is the purpose of the Title 1 program?

The purpose is to ensure that all children have a fair, equal, and significant opportunity to obtain a high-quality education and reach their full potential.

This purpose can be accomplished by:

1. Creating a system of communication between classroom teachers, support staff, and parents so that all groups are working toward the same goal.
2. Administering and analyzing a variety of high quality assessments to identify which students will need additional instruction (including, state assessments, classroom tests, STAR, etc.)
3. Providing evidence-based instruction from high quality curriculum that has been scientifically proven to advance the skills of students who may be struggling.

What can parents do to help?

- *Read with your child for a minimum of 20 minutes a day.
- *Ensure your child attends school regularly.
- *Support your child when completing homework or studying.
- *Encourage your child to do his/her very best at school.
- *Monitor your child's progress by logging into ProgressBook.
- *Participate in parent teacher conferences.
- *Engage your child in conversation about school.

What does Title I services mean for your child?

- He/She will receive instruction in exactly the areas that need intervention (decoding, phonological awareness, letter naming, comprehension strategies, addition, place value, etc.) only when your child needs it.
- Continuous monitoring of the progress your child is making so adjustments can be made if necessary.
- He/She may move in and out of Title I groups throughout the year, depending on progress.



How are Title I services provided?

Title I services may be offered in a variety of ways, such as:

- Classroom teacher works with the student within a small group or individually.
- Title I staff works with a student within a small group or individually.
- Title I teachers may co-teach with a classroom teacher.
- Resources used during instruction might include using the Language Arts program, a computer based program, or research based strategies.
- Intervention may happen inside or outside of the classroom.
- Title I services will mostly occur during a “no new instruction” time.

Notice of Parents’ Right to Know

Notice of Right to Know Teacher Qualifications

You have the right to know about the teaching qualifications of your child’s classroom teacher in a school receiving Title I funds. The federal Every Student Succeeds Act (ESSA) requires that any school district receiving Title I funds must notify parents of each student attending any school receiving Title I funds that they may request, and the district will provide the parents on request (and in a timely manner), information regarding the professional qualifications of the student’s classroom teachers, including at a minimum, the following:

- I. Whether the teacher has met State qualification and licensing criteria for the grade levels and subject areas in which the teacher provides instruction;
- II. Whether the teacher is teaching under emergency or other provisional status through which State qualification or licensing criteria have been waived; and
- III. Whether the teacher is teaching in the field of discipline of the certification of the teacher;
- IV. Whether your child is provided services by paraprofessionals and, if so, their qualifications. All requests must be made in writing and should include the following information: student’s full name, legal parent/guardian’s full name, address, city, state, zip code and teacher’s name.
